A. Would you be willing to sign an amended Covenant that would include an assessment that would be tied to the life of the land as the current Covenants do?

To those who still question the value of Tierra Grande Improvement Association, here is some food for thought.

Without continued income of some kind landowners would experience the following probabilities:

•CLOSED: <u>NO</u> access to an Administrative office to hear and act upon members' concerns. No newsletter to inform and accommodate members' activities. No access to maps and account information

•GONE: Financial means to enforce the covenants through the Architectural Control Committee. Some people believe the County will enforce the covenants. Be assured that the County will <u>NOT</u> enforce the covenants. Members may contact County Code Enforcement or Planning and Zoning in either Valencia or Socorro County to ask about covenant enforcement.

•FORFEITED: Tierra Grande's Open Space. No funds will be available to pay over \$4,000 in Valencia, Socorro and Torrance Counties property taxes.

•GONE: No Director supervision over the developments in Tierra Grande which necessitate accounting, banking, realty and residential expertise.

•**FOREFEITED:** Tierra Grande's Fire Station. No funds to pay the property taxes.

•GONE: Revenue to fund signs or lights or archways or fencing or access easements or special projects for the Tierra Grande community

#### Articles of Incorporation Clear

The Articles of Incorporation are quite clear:

Members will no longer be members when the Indentures expire because paying the Indentures is what defines someone as a member.

"Those owners whose Unit DOES NOT vote to continue the Indentures will simply no longer be members of TGIA by definition when their lots are no longer subject to assessment."

Also: "Upon dissolution or other termination of the Corporation, NO PART OF THE PROP-ERTY of the Corporation, NOR ANY OF THE PROCEEDS THEREOF, shall be distributed to the members of the Corporation . . . "

This is a lot of information to take in at one time, but it is meant to inform so that you, as a member, can make your decision to amend the covenants based on the facts.

Within the next few months as decisions are made, more information will be sent to keep you apprised of the status of the continuation of Tierra Grande beyond 2013.

The TGIA Board and Administration are listening to your concerns and making every effort to assure that TGIA's continuation is beneficial to all members.

### PNM Replacing Poles Along Highway 47 Tierra Grande owners who drive Highway 47

Tierra Grande owners who drive Highway 47 may have noticed the new power poles installed on the west side of the highway in Tierra Grande.

This project has nothing to do with power in or to Tierra Grande, but is a PNM initiative to connect and replace a 115kV line which runs from PNM's Belen switching station east for approximately 50 miles to PNM's Willard switching station.

The phases for this project are:

Phase 1 – Gate installation in certain areas – completed.

Phase 2 – Construction and erecting of new poles – completed.

Phase 3 – Installation of new conductor (wire) – in process.

Phase 4 – Dismantlement of old transmission line, clean up and remediation activities – anticipated completion summer of 2010.

# Wire Tapping Along The SEC Power Lines

The subject is wire THEFT – copper wire. Over 200 Socorro Electric power poles in Tierra Grande and the surrounding area have been stripped of their copper ground wires.

The cost to repair this damage is over \$50,000.

This theft also means that Tierra Grande power poles are not grounded. It means a fluctuation in the integrity of power that travels through the lines. It means potentially more power outages until the repair is completed. It means that if lightening strikes an ungrounded pole a fire could result.

Socorro Electric Cooperative officials are asking Tierra Grande residents to keep their eyes open.

When you see anyone suspicious lurking around the power poles, DO NOT approach.

If possible, take down the license number and a description of the vehicle and person(s) also note the date and time of the event.

Then call the TGIA office at 864-2345 to coordinate efforts to catch these culprits.

These thefts directly affect the welfare of the Tierra Grande Community.

### Vacant Homes Need Protection

Vacant homes are an easy target for thieves. Whether the home is vacant for a few weeks – or even just a few days - it is important to inform a neighbor you trust or a neighborhood watch captain that you will be away.

Provide them with a phone number where you may be reached - should some issue arise.

One recommendation from a Tierra Grande resident is to place a stout chain across your gate and post as well.

### You and Cattle in Tierra Grande

While grazing cattle is against Tierra Grande covenants, in the past the Association addressed this issue in court and lost. New Mexico currently is still an open range state. Accordingly, it is a landowner's responsibility to fence their property to keep animals out.

# Unpaid Assessments, Changes, Foreclosures

Unpaid Assessments for 2009 have begun to accrue interest at the rate of 8% per annum.

Accounts that are delinquent in the 4th year of nonpayment are being sent to legal counsel to begin foreclosure proceedings. Full payment of past due assessments and an additional fee of \$200 per delinquent lot will be charged to owners who would like to remove their property from the foreclosure process.

If events in your life create changes (such as moving, marriage, divorce, adding/removing dependents, death, lot split) and you want to make a change to the title of your Tierra Grande property, you first need to make the change with the County Clerk in which your property is located. The numbers are:


# Time to Remove Dead Trees & Shrubs from Your Property
