Why Have An Improvement Association?

The question of why there is an Improvement Association is asked by Tierra Grande owners quite frequently, especially new owners. Each year since 2011, the first issue of the Tales 'n' Trails newsletter informs members of what has been accomplished by TGIA in the previous year. Here is additional information about the limitations placed upon the Association.

TGIA is a NON-PROFIT organization incorporated at the direction of Horizon Corporation, the original developer. TGIA cannot perform any function normally attributed to a land developer and still retain its tax exempt status under IRS regulations.

The Association is operating legally when helping offset the cost of maintenance and improvements to the Fire Station, the Open Space property, power lines, roads, and equipment, as funds become available.

The TGIA Administrator is available to all members in good standing to answer questions or assist in county tax or property deed change problems. She will direct you to the approximate location of your property when you visit.

If no Association with its Indenture and Covenants requiring an annual assessment existed, the following could prevail:

• Ongoing maintenance and covenant enforcement would be at the owners expense and very costly.

• Buildings such as rough shacks, decrepit trails, etc., could proliferate without the restrictions presently in effect, thereby greatly reducing the value of properties.

• Lots would be split to less than the current five-acre minimum required by the covenants

• No one would be available to help landowners find answers to the numerous questions that arise each day.

Administrative salaries and directors fees are listed in each annual audit report, with the directors fees representing less than 7% of the budget.

Your Board of Directors meets at least once a month during the business day, taking time from their livelihoods to protect your investment in Tierra Grande. In addition, the administrator and board members drive through Tierra Grande checking the roads and looking for any problems.

The use or non-use of Tierra Grande land is an individual choice, as TGIA is prevented by law from acting as a developer. The original seller and developer, Horizon Corporation, established TGIA to represent Tierra Grande land owners, collect established charges, and enforce covenants.

Some owners have questioned what is the next "Five Year Plan." Your Board has given serious consideration to this subject and feels future expenditures with no foreseeable benefits to a great number of members should be held off. An example is the rather extensive and expensive power line extension built through Units 5, 9, 10, 18, 20, 21, 22, 23, and 24 several years ago which resulted in only a few homes being built. In some areas, no homes were built.

Building the Tierra Grande Fire Station benefitted the membership as homeowner insurance costs were greatly reduced. Response time to a fire in our community has been shortened whether fire personnel are responding to a house fire, wild land fire, or medical emergency. The Association pays the annual taxes on this property as well as the property insurance. The savings on homeowner insurance more than offsets the annual costs.

Over the next five years the Board will focus on:

• Serving the greater good of the Tierra Grande community;

- Protecting the Open Space;
- Reducing costs; and
- Maximizing revenue

This 'n' That Around the Tierra Grande Community

The April 19, 2014, Community Watch Meeting drew 35 members. Ernie Nagy, Watch Coordinator, led the meeting.

Steven Gonzales, Fire Chief for the Rio Grande/Tierra Grande Estates Fire Departments, answered questions about the proposed transfer of the lease of the Tierra Grande Fire Station from Valencia County to the City of Rio Communities. Rio Communities Mayor Mark Gwinn was on hand as well.

When the transfer occurs, the only change will be that the City of Rio Communities will eventually become the fiscal pass-through agent for the fire funds distributed by the State of New Mexico to community fire departments.

During the first year of the transition, the Mid Region Council of Governments will handle the fiscal responsibility of the fire funds to give the City of Rio Communities the opportunity to set up a budget and put in place the fiscal components required to manage the funds.

The Fire Department will maintain the responsibility/ authority to spend fire funds under the governing laws and requirements. TGIA will retain ownership of the fire station. The transition should be seamless. Most participants left the meeting with a better understanding of the process.
