Catching Up on Tierra Grande Activities

The May Community Watch meeting covered a variety of topics involving life in and around Tierra Grande. Community Watch Coordinator Ernie Nagy opened the meeting.

Tierra Grande Fire Station – When approved by the State Fire Marshal, the Tierra Grande and Rio Grande Estates Fire Stations will become aligned with the City of Rio Communities. Funding will then pass through Rio Communities. The leadership and association will remain the same. Tierra Grande owns the fire station which will be leased to the City. Improved fire service is expected as a result of the transition.

Volunteers – Volunteer firefighters and EMTs are needed. Training is provided. If you are interested, apply after the station transfer has been finalized.

Rural Addressing – Tierra Grande residential addresses should be four-inch-high numbers on a reflective background to help emergency responders. The numbers can be purchased at Valencia County rural addressing or Home Depot, Lowe's or Walmart.

Safety Reminder -- Residents are encouraged to familiarize themselves with vehicles in the neighborhood and know their neighbors to keep the area safe. If an alarm system is considered – an external strobe light and an external horn are two of the best deterrents. A resident recently had an alarm system installed by Alpha Alarm Inc. which offers residents a discount. Phone 505 553-5402 (Troy Brown).

No Facebook Page – Those attending the meeting agreed a Tierra Grande Facebook page would not be appropriate at this time. People felt that the current way of passing on news about the area is sufficient.

Socorro Electric Co-op – The result of the Socorro Electric Co-op vote was that the reform group lost the vote. The reform group was present in the majority but the mail-in ballots outweighed those present.

Some felt ballots were very confusing. Election results might mean an increase in electric rates to fund two more trustees and proposed bylaws changes will not take place.

Roads – Talks continue with the Road Department regarding regular grading of the main roads, grading of nec-

essary roads, and not grading roads in good shape. TGIA and Valencia County are working together to improve portions of Manzanita.

Annual Cleanup – As soon as the date has been set for the annual cleanup, an email will be sent.

Next Meeting – Community Watch meets at the Tierra Grande Fire Station Saturday, October 17, at 11 a.m.

Snippets from the Past Why TGIA? – Why Me?

Excerpt from the August 1977 TGIA Newsletter

Probably the most frequently asked questions we receive from members involve the general purposes of the Association and its automatic membership feature. Without getting too technical, members who purchase property in Tierra Grande should have received copies of the Association's Articles of Incorporation, Bylaws and Indenture, which contain all of the pertinent provisions regarding TGIA and its membership requirements.

TGIA is a not-for-profit income tax exempt corporation representing the interest of its members. The basic concept in its formation was to provide property owners in the Tierra Grande community with a vehicle for covering costs of common space, maintenance programs, and fire prevention.


TGIA's overall purpose is to promote the common good of the Tierra Grande area with regard to safety, culture, covenant enforcement, architectural control, communication with and assistance to members. Through the faithful payment by each member of the nominal annual charge per lot owned, when pooled and invested in interest bearing depositories, monies are available to effect a betterment of the community which will inure to the ultimate benefit of owners of property within the community. It should be clearly understood, however that TGIA funds will not be used to make improvements on privately owned individual lots.

The Indenture provided that interest may be charged on delinquent annual charges and gives the Association the right to enforce a lien against lots for which the annual charges remain unpaid. Thus, since the funds of the Association are to be used for the common good of the community, all members should contribute toward its funding.

Each member in good standing is entitled to use TGIA Open Space and may vote in membership elections at the rate of one vote for each lot owned. The five member Board of Directors guides the association and makes decisions concerning expenditure of funds. The members elect one Director at the annual membership meeting to fill vacancies created by the five year staggered terms of the Directors. Members are encouraged to attend these meetings. The Board members have consistently acted to the best interests of TGIA and its membership. Both because of the legal fiduciary obligations of the office and their own personal standards.

This article, written in 1977, holds true today to the vision and standards of TGIA and its Board.

Kinder Morgan has changed its focus to projects other than the pipeline.
