TGIA Accomplishments 2015

During 2015, your annual assessments supported the common good of the Tierra Grande community. Together we have:

• Continued to keep the cost of day-to-day operations under control

Protected TGIA-owned properties from tax increases

 Sold 17 TGIA owned lots – recouping expenses and earning assessments

• Received 5 donated lots from TGIA members

• Cleared 19 property ownership/titles with the Valencia County Assessor's office

• Cleared up an additional five errors in property ownership with Socorro County

• Filed 5 death certificates, where owners were joint tenants, for Valencia County owners at no cost

• Organized a community cleanup with 2 dumpsters provided at no cost from Valencia County

• Remedied a serious erosion area that was a danger to travelers in Tierra Grande

• Transferred the operation of the TGIA-owned fire station to the City of Rio Communities Fire Department

 Achieved property tax exempt status for the TGIA fire station

• Worked with Plateau Communications to bring fiber optic cables through the southwest section of Tierra Grande

• Researched non-profit status for the Open Space

• Through good financial oversight, there has been no TGIA assessment increase since 1995

On a Day-to-Day Basis Provided Ongoing Service to Our Members –

• Worked with the Valencia County Road Department to maintain Tierra Grande roads on a routine basis

• Worked with the Valencia County Sheriff to ensure adequate police protection for residents

• Protected the Open Space by communicating with members, the BNSF railroad, and Fish & Game

• Achieved another successful financial audit/review

Maintained financial stability and integrity

• Maintained the Little Free Library within the Tierra Grande Community

• Worked with Community Watch to help keep Tierra Grande one of the safest communities in Valencia/Socorro Counties

• Worked with Valencia County representatives on issues related to Tierra Grande

• Attended and communicated with area governments and attended community meetings to keep TGIA abreast of developments and information

 Enforced the Protective Covenants to accommodate as many different people with their needs who make Tierra Grande a diverse and welcoming community.

 Paid the insurance and property taxes on the Open Space and TGIA (\$10,000 +)

• Worked with cattle grazers, developers, and individuals with vested interests in Tierra Grande

 Communicated with TGIA members via email about issues related to the community

• Tierra Grande has almost 2,600 land owners. During 2015 the office answered their calls, met with many directly, represented the membership when necessary, and responded to member issues and concerns professionally and as quickly as possible.

Snippets from TGIA's Past

Enjoy these shared memories about Tierra Grande:

<u>1983</u> — TGIA renewed the range management agreement, limited to the eastern Open Space, with a local rancher, for five years. The intent of the agreement was to eliminate overgrazing that trespassers in the past had been guilty of.

<u>1984</u> — TGIA began providing a looped electrical system that extended the power from Unit 13 through to Unit 24 in Valencia County on the east side of the community and proceeded south and west to Units 10, 11, 12 in Socorro County.

<u>**1985</u>** — TGIA office opened in Rio Communities. TGIA purchased its first computer and the process began of separating Tierra Grande from Horizon Corporation.</u>

<u>1986</u> — TGIA worked with officials to improve roads in both Valencia and Socorro Counties so that the Counties would accept and maintain such roads. Valencia County followed through by accepting many roads and maintaining these roads to date. Socorro County does not maintain any roads in Tierra Grande.

<u>1987</u> — TGIA secured ownership of Black Butte Park from Horizon Corporation. Billboards were erected welcoming people to the Tierra Grande covenant-protected community.

Pay Attention to Property Value Notice

Each early spring a notice of property value is mailed to every Tierra Grande property owner from the Valencia and Socorro County Assessors. A window of opportunity exists to protest the property value which is the basis for the property tax. The protest period <u>ends</u> April 30 of each year.

Many Socorro County property owners experienced a significant increase in property taxes in 2014. That increase might have been reduced by contacting the Socorro County Assessor's office to request a protest form at 575 835-0714.

Whenever completing a protest form be sure to have the Notice of Value in front of you.

Help Keep Records Up To Date

It is very important Tierra Grande be kept up to date regarding changes to the ownership information of Tierra Grande lots.

Let TGIA know when the following changes occur:

- Change of address,
- Change of ownership,
- Death of an owner,
- Putting the property in a trust,

• Appointing a trustee/executor authorized to handle property affairs.

Unpaid Assessments Accrue, Send Change Info to TGIA

Unpaid Assessments for 2015 have begun to accrue interest at the rate of eight percent per annum.

Accounts delinquent in the third year of nonpayment are sent to legal counsel to begin foreclosure proceedings. Payment in full for past due assessments plus interest plus \$200 for the cost of a title search must be recovered from owners who want to remove their lot from further legal proceedings.

If you want to make a change to the title of your Tierra Grande property, you first need to make the change with the County Clerk where your property is located. The numbers are:

Valencia County Clerk 505 866-2073

Socorro County Clerk 575 835-0423

Once that has been done then contact Tierra Grande to change records accordingly.

Community Watch Meeting Held

On Saturday, October 17, 2015, about 22 Tierra Grande residents gathered for a Community Watch Meeting. Ernie Nagy, Watch Coordinator, reported on events in Tierra Grande over the past six months. Of primary concern was a vacant home in foreclosure that had been vandalized. Community Watch members and Tierra Grande staff, as well as Valencia County Sheriff's Detective Otto King with Wells Fargo Home Mortgage, worked together to secure the home.

Other items discussed were:

The Keep New Mexico Beautiful Cleanup in October which included two donated dumpsters. Tierra Grande members in good standing used the dumpsters to dispose of their miscellaneous items with everything accepted. People brought any trash they found along their area roadways to help keep the community clean.

The Little Free Library appears to be working well. Sue Moran, Administrator, thanked everyone who donated books.

There has been some problem with the community email directory. Sue will send out a verification of address to those currently on the list. Those interested in continuing to receive email from the TGIA office, should respond. Those who do not respond will be removed.

Concerns regarding road conditions were expressed. Many residents try to repair the roadway near their homes when immediate problems arise. TGIA is working with area Valencia County Commissioner David Hyder and new Valencia County Public Works Director, Lina Benavidez to partner in resolving some of these issues. It is hopeful that an arrangement can be achieved.

The process will be:

• Complete the authorization form above and mail to TGIA. Do not staple, use tape. Postage is required.

• No submission will be accepted without a signed authorization form.

• A chart will be compiled showing only the Unit/ Block/Lot, # of Acres and the Asking Price. NO personal information will be released.
