Roads, Other Items Discussed at Meeting

One of the biggest challenges in Tierra Grande is dealing with the roads in the subdivision, said TGIA Board President Dave Tibbets at the 2016 annual meeting.

"It has become clear to me that we don't have resources as an organization to improve the roads," said Tibbets who pointed out Valencia County needs to lead the way on improving the roads.

Administrator Sue Moran has worked out a plan with the county for roads. TGIA will provide the base course and crusher fines and Valencia County will provide the manpower.

Sue has talked continually with Valencia County officials about the road situation. Everyone is now working together to keep an eye on the conditions of the roads.

TGIA only has \$10,000 a year to spend on road improvements.

Since 1995 the TGIA board has avoided raising the annual fees. There are no future plans to raise the fees.

An innovation this year is the For Sale By Owner list of properties on the TGIA website.

The computer system at the TGIA office has been upgraded and updated which has increased the efficiency of the organization.

Land on either side of the fire station on Highway 47 just north of Tierra Grande has been acquired with a remodel of the station to take place.

Thought is being given to constructing a helicopter pad and/or a training facility at the station.

The ISO rating for various sections of Tierra Grande has changed. Some areas will have a lower rating while others will have a higher rating. See separate story in this newsletter.

A devastating forest fire in the northern Manzano Mountains destroyed homes and other buildings in 2016. A small fire was extinguished before it could do any damage in Tierra Grande.

Both TGIA President Tibbetts and Adminis-

trator Moran encouraged Tierra Grande residents to be extremely careful. Rain has been scarce in 2016 and fire can start and spread quickly.

Treasurer Says

TGIA In Excellent Financial Condition

"TGIA is a very strong and stable organization thanks to the wonderful members who recognize the unique opportunities TGIA offers," said TGIA Treasurer Judi Magnussen at the 2016 annual meeting.

She pointed out that most, if not all, the membership, is aware of the benefits of owning property in and being members of TGIA.

Financials show land sales in the negative which is caused by donated land placed on the books at an unrealistic value. In the future, said Magnussen, donated land will be recorded at a lower value.

Total equity is \$1,080,907 which includes \$432,801 in cash with liabilities of \$46,048,

Income consists of assessments of \$124,761 plus interest income, the tower lease, and donated land.

Operating expenses were lower in 2015 than in 2014 thanks to the efforts of TGIA Administrator Sue Moran. Plus, operating costs were held in check.

Magnussen concluded by saying "TGIA is in great shape for now and for the future." She thanked everyone for their continuing support.

Electric Co-op Chief Speaks at Meeting

Electricity in Tierra Grande is provided by the Socorro Electric Cooperative (SEC) so it was quite apropos that Joseph Herrera spoke at the 2016 TGIA annual meeting.

Herrera is SEC manager. He covered a wide variety of topics at the meeting, many based on his five year experience with the co-op, as it is called by many people.

In 2015 SEC board members hired a consultant to rewrite the organization's bylaws which dated from the 1940s.

Herrera said the consultant did a lot of intake from the membership and others. New bylaws were voted in by the membership in 2015. Along with the new bylaws came policies that worked parallel with the bylaws and do not conflict.

The board went from five to seven with passage of the new bylaws. Herrera said various legal issues have been left behind with the new bylaws.

The SEC board wants to keep rates as low as possible and make sure management does what it is supposed to do.

Herrera said SEC board members are now working together with a budget that is strictly adhered to. The organization is using the principles of best business practices.

Herrera pointed out that Tri-State Generation and Transmission supplies the power for the 11,000 square miles that SEC serves.

In 2015 the SEC board had its first strategic planning session and picked priorities which include member engagement, increased transparency, and feedback from members. A new position is director of communications, which will help provide better customer service.

Foreclosure Sale Scheduled

A foreclosure sale will be scheduled before the end of 2016.

Assessments / Tax Bills Sent in Fall

TGIA assessments are sent to land owners in October each year. Assessments are billed in arrears, meaning assessments are applied to 2016. Assessment payments are due by December 31, 2016. Assessments paid after December 31 start accumulating interest at eight percent per annum.

Owners of lots in the third year of non-payment are notified on the assessment bills that in January the account will be sent to legal counsel to begin foreclosure. Once proceedings begin, an additional \$200 fee is incurred on each lot in foreclosure plus legal fees.

Assessment payments are sent to TGIA at PO Box 1388, Rio Communities, NM 87002.

Property tax notices are sent by County Treasurers the beginning of November with payment due in December of the same year. Property tax payments should be sent to the treasurer of the county where the property is located. Do not send to TGIA.

Bighorn Sheep Habitat To Be Improved

National Forest Improvements Detailed

During Fiscal Year 2017, the habitat of the Bighorn Sheep in the southern Manzano Mountains will be improved, said Chuck Schultz, Northwest Regional Habitat Biologist with the Wildlife Management Division of the New Mexico Department of Game and Fish speaking at the TGIA 2016 annual meeting.

Schultz discussed a variety of projects that will be undertaken in New Mexico's national forests.

In the Cibola National Forest (Mount Taylor district) on Black Mesa/Chiato Mesa there is an ongoing elk calf mortality study plus habitat improvement and enhancement as well as prescribed burns.

In the Santa Fe National Forest thinning and prescribed burns are scheduled with a 21,000-acre burn block identified.

Thinning, sage mowing and seeding will be conducted in the Carson National Forest Jicarilla area with over \$20,000 in seed mix distributed.

The Cibola National Forest is collaborating with a broad array of partners on a Collaborative Forest Landscape Restoration Program in the Zuni Mountains,.

A variety of improvements, including aspen regeneration, have been accomplished in the Zuni Mountains thanks to the collaboration.

Zack Parsons, Wildlife, Fish and Rare Plant Program Manager for the U.S. Forest Service, discussed the Southern Manzano Landscape Restoration Project at the annual meeting.
