

Assessments Support the Common Good

TGIA President Judi Magnussen told those attending the July 2017 annual meeting about last year's accomplishments of the organization.

She pointed out that your assessments support the common good of the Tierra Grande community. Working together, last year's accomplishments include:

• Lowering the cost of day to day operations.

- Protecting TGIA-owned properties from tax increases
- Organizing community cleanups with Valencia County dumpsters provided at no cost.
- Partnering with the Valencia County Road Department to repair road areas in need of gravel.
- Paying for and installing a bathroom/shower stall at the Fire Station so volunteers can shower before going to work.
- Paying for cleanup of two areas in Tierra Grande where illegal dumping occurred.
- Paying the insurance and property taxes on the Open Space and TGIA property which amounts to over \$10,000.
- Working with universities and the NM Geological Society to allow access to TGIA Open Space for the education of students and faculty.
- Developing and marketing a For Sale by Owner catalog to help owners sell their property.

Land Scammers Active!

If an offer sounds too good to be true, it is most likely a scam.

TGIA has received calls from members who have been approached with offers to purchase their vacant lots for a high dollar amount – all the seller has to do is give the buyer their bank account or credit card number! Don't do it.

The name of one company TGIA has received complaints about is We Buy Vacant Land.

Remember that a legitimate buyer will give the seller a cashier's check or use PayPal to purchase a property.

Also, property management companies are trying to sell you services. We have heard that the American Association of Land Owners will provide you with pictures and various market analyses, marketing suggestions and a list of brokers in the area for a mere \$94.

Another name that pops up is the Rio Communities Landowners Association – for \$50 a year they provide you with information about your vacant land. We have seen these documents and they are not pertinent to Tierra Grande.

Two Different Bills, Two Different Payments

Every Fall TGIA land owners receive two bills for their property—

- One bill is for the TGIA assessment on the property
- The second bill is the property tax assessed by the county where that property is located.

These are two completely separate bills. Your payments should be sent to two different organizations:

The assessment, due by Dec. 31, is paid to TGIA. Assessment notices are sent to Tierra Grande land owners in October.

The assessment is part of the covenants which protect Tierra Grande.

The property tax is paid to either the Valencia County Treasurer or the Socorro County Treasurer, depending on where the property is located.

Property tax bills are sent by the County Treasurers the beginning of November with payment due in December of the same year.

It is extremely important to pay both these bills each year. It is extremely important to know that these are two separate bills, payable to two separate entities

Just as important is to notify each entity of any address change involving these bills. If the address for where your bills are sent changes, inform both TGIA and the Valencia or Socorro County Treasurers as soon as possible.
