TGIA Accomplishments in 2017

Dear Members,

During 2017, your annual assessments supported the common good of the Tierra Grande community. Together we have:

- Kept the cost of day-to-day operations in check
- Increased revenue
- Protected TGIA-owned properties from tax increases
- Received two donated lots from TGIA members
- Sold 20 TGIA-owned lots to reduce property taxes and increase assessment earnings and revenue
- Cleared up 12 property ownership/titles with the Valencia County and Socorro County Assessor's offices
- Filed 10 death certificates, where owners were joint tenants, for Valencia County owners at no cost
- Organized a community cleanup with two dumpsters provided at no cost from Valencia County
- Paid to remedy another serious erosion area that was a danger to travelers in Tierra Grande
- Partnered with the Valencia County Road Department to repair roads and paid for gravel for roads
- Partnered with the Valencia County and Socorro County Treasurers to notify over 125 members whose properties were in arrears on payment of property tax – saving many properties from being sold at a tax sale
- Partnered with the Valencia County and Socorro County Assessors to update over 200 owner addresses
- Developed an ongoing relationship with the Valencia County and Socorro County Assessors to forward updated owner contact information
- Transferred the Tierra Grande Fire Station to the City of Rio Communities so the station can receive funding to expand and equip the station
- Marketed the For Sale By Owner catalog to help owners sell their lots – to date 38 properties have sold
- Worked with Universities and the NM Geological Society to allow access to Tierra Grande Open Space
- Communicated with NM Dept. of Game & Fish and the U.S. Forest Service to protect the Open Space
- Worked with Tierra Grande members to protect the Open Space by installing gates at the north and south end of Sand Canyon

- Developed a permit policy for owners who wish to drive vehicles in our Open Space
- Worked to create a sense of community through weekly information sharing, community watch involvement, and being responsive to members
- Arranged a solar power presentation for members
- Coordinated VIN etching project with the Valencia County Sheriff's Department for member vehicles
 - Paid for the cleanup of trash
- Implemented a lien policy for lots with structures which are in arrears on payment of assessments
 - Updated TGIA's five-year goals and objectives
- Successfully protested changes to State Bill 244 regarding Home Owner Associations
 - Completed a successful audit/review for 2016
- Celebrated the 3rd anniversary of our Little Free Library
- Through continued good financial oversight, assessments have not increased since 1995

On a day-to-day basis, TGIA has provided ongoing service to members by

- Working with Valencia County representatives, commissioner and sheriff on Tierra Grande issues
- Communicating with area governments and attending community meetings to keep abreast of developments and information
- Enforcing the Protective Covenants to accommodate different people with their needs to make Tierra Grande a diverse and welcoming community
- Paying the insurance and property taxes on the Open Space and TGIA (\$10,000 +)
- Working with cattle grazers, developers, and individuals with vested interests in Tierra Grande
- Providing notary services at no charge, as well as copy and fax services to members in good standing

Tierra Grande has almost 2,600 land owners. During 2017, the office answered their calls, met with many directly, represented the membership when necessary, and responded to member issues and concerns professionally and as quickly as possible.

Community Watch

On Saturday, Oct. 21, 2017, some 30 Tierra Grande members gathered at the Tierra Grande Fire Station for a great semi-annual Community Watch meeting.

Thank you to all who attended to make it a success. Some folks took advantage of the free VIN etching offered by the Valencia County Sheriff's Dept. Deputies answered questions while the fire and rescue staff verified that people can walk into the fire station to seek medical services if it is staffed.

Watch Coordinator Ernie Nagy reported there were no outside incidents. The new trash ordinance as well as the possibility of holding a presentation regarding solar energy for residences were discussed.

Upcoming Community Watch Meeting

The next meeting for the Community Watch has been tentatively scheduled for Saturday, April 28, 2018, from 11 a.m. to 1 p.m. at the Tierra Grande Fire Station.

Solar Energy Presentation

On Saturday, Dec. 9, 2017, a meeting regarding solar options took place at the TGIA office with about 25 people attending.

Thank you to Jim Thomas and Ward McCartney, Tierra Grande residents, who shared their experience with solar panels.

Representatives from SunPower by Positive Energy Solar and Affordable Solar attended the meeting. These two companies are the largest and highest rated solar providers in New Mexico.

Meeting discussion centered on a cost effective way to operate pumps/wells when the power goes out. TGIA staff will explore options and reach out to the members when solid information is available.

Pay Attention to Property Value Notice

Each early spring, a Notice of Property Value is mailed to property owners from either the Valencia County Assessor OR the Socorro County Assessor, depending on where your Tierra Grande property is located.

A window of opportunity exists to protest the property value, which is the basis for the property tax. The protest period generally ends at the close of April.

Architectural Control Committee Supports Protective Covenants

The Protective Covenants are the restrictions imposed upon the land which provide a general scheme for good land planning and design. For example, a minimum of five acres per lot, easement requirements, single family residential dwelling and outbuilding specifications, no gas or oil drilling or mining, no gravel or quarry operation of any kind, no more than two horses per five acre lot size, etc.

- The Protective Covenants run with the life of the
- Architectural Control Committee reviews and approves/denies/amends all construction and or building plans
- \bullet Only the landowners of Tierra Grande lots can amend the Protective Covenants by an approval vote of 51%
- In 2013 landowners in each unit amended the Protective Covenants to incorporate the Indenture into the Protective Covenants, which is the means for collecting assessments for providing Tierra Grande, a non-profit civic organization, to serve as the representative of lot owners, the enforcement of all covenants, and the creation, operation, management and maintenance of the Open Space and other activities applicable to the enhancement of Tierra Grande.

Unpaid Assessments Accrue

Unpaid Assessments for 2017 have begun to accrue interest at the rate of eight percent per annum.

Accounts delinquent in the third year of nonpayment are sent to legal counsel to begin foreclosure proceedings. Payment in full for past due assessments plus interest plus \$200 for the cost of a title search must be recovered from owners who want to remove their lot from further legal proceedings.
